DIVIDEND

Due to the volatility of the interest market, the Board must adjust loan rates as follows.
PRIME RATE @ 7.50%

**DIVIDEND @ 1.25% bp's WITH over \$400-25K
@ 2.50% bp's WITH over \$25K-75K
@ 3.50% bp's WITH over \$75K-250K**

CONSUMER LOAN

Maximum \$20,000—or \$20,000 w/ 1 Co-maker
(36mos @ 8.25%) (48mos @ 9.25%) (60mos @ 10.50%)
